Hong Kong International Printing & Packaging Fair 2017 Special Move-in / Move Out Arrangement

Thank you for your participation at the Hong Kong International Printing & Packaging Fair 2017.

Special Move-in Arrangement

It is just informed by the venue operator, AsiaWorld-Expo (AWE) that enhanced security measures will be imposed at the fairground during the move-in period, i.e. 25-26 April (Tue-Wed) of Hong Kong International Printing & Packaging Fair 2017.

- 1. All passengers and drivers accessing the venue by vehicles via the marshaling area have to present their identity documents for registration by the AWE Security. The drivers also have to provide their mobile phone number for necessary contact in case they left the vehicle at the loading area for goods delivery. A wrist band will be provided by AWE in return.
- 2. Contractors and construction workers accessing the fairground have to approach the "Green Card Counter" located at the East Lobby and present their Construction Industry Safety Training Certificates (also known as "Green Card") for registration and collection of wrist bands.

Those with exhibitor badges or any other valid badges may enter the venue as usual.

Special Arrangement on 30 April (Move-out)

On the other hand, it is also informed that the President of Indonesia, Joko Widodo, will pay a visit to AWE to greet the Indonesian residing in Hong Kong on 30 April (Sun). In accordance to the Hong Kong Special Administrative Region's protocol of welcoming Head of States, the Hong Kong Police Force (Police) will impose high level of security measures and operation at AWE during the visit.

1. Pre-event Venue Sweeping

The Police will conduct a thorough inspection and venue sweeping after the Fair closes on 29 April till 30 April morning. The whole operation will be carried out by the Police Search Team accompanied by AWE security guards. Exhibition stands with cabinets may be opened by the Police for inspection while AWE security guards will take record on the search register. It is therefore advised that all exhibitors should arrange their exhibits properly and not to leave any valuables inside their booths during the mentioned period to avoid any possible lose.

2. Security Screening Point

Security screening points with x-ray machines and metal detectors will be set up on the event date (30 April) at all AWE entrances starting from 6:00 am - 6:00pm. All visitors accessing AWE will have to go through the security screening. Exhibitors are advised to arrive at the venue earlier as it may take longer time to access the fairground.

3. Special Move-out Arrangement

All service roads around AWE will be sealed off for vehicle traffic between 12:00 mid-night and 6:00pm on 30 April and move-out has to be arranged after 6:00pm with the Vehicle Permit provided previously. Exhibitors are advised to inform their freight forwarder accordingly. In case onsite freight forwarding services is needed, exhibitors may approach the Official Freight Forwarder at the service counter opposite to booth 3-J02 in Hall 3.
